# **Outline Syllabus**

The syllabus will emerge from sources of information provided by researchers running experiments that students take part in. One 2-hour lecture will provide information about the nature of assessment, learning activities and guidance on how to complete assessments. Another 2-hour lecture will cover ethical issues in psychology research and also in professional practice. Tutorials will cover issues raised in the lectures in more detail, and provide students with the opportunity to discuss these issues in small groups.
