#### **Notes**

This practice-based module introduces the student to a key aspect of the non emergency role. It addressed aspects of non-urgent care, through a model of increasing levels of dependency, immediacy and urgency. Hence, as the module draws to a close the student will be introduced to high dependency care.
