Outline Syllabus:

The module will begin with lectures on a variety of aspects of performance in contemporary and historical contexts with appropriate, accompanying theatre visits. Discussion in seminar groups and tutorials will focus on the social, economic and political contexts in which these theatre texts were created, as well as introducing strategies for performance analysis. For example, a visit to a production of John Ford's 'Tis Pity She's a Whore would be accompanied by a lecture on Jacobean tragedy and contemporary cultural influences and a seminar discussion of the production, applying a range of Performance Analysis approaches. As the module progresses, students in small groups will offer presentations on a range of post World War II theatre texts.
