This module provides a theoretical base for the students' development to understand the fundamentals of pharmacology within the context of paramedic practice. The students will be qualified and employed as an Emergency Care Technician 1. An EMT1 can administer a range of medications and they also support EMT2 and paramedics in preparing medications for administration within their scope of practice. The module content will enhance their current experience and scope of practice and prepare them for further developments as they potentially progress.

- 1. The programme code is 25666 and is approved for a June intake. There is no PSRB requirements. The module learning outcomes are in line with the level 4 descriptors of the Framework for Higher Education Qualifications of UK Degree-Awarding Bodies.
- 2. The module involves classroom attendance, which is further supported by a range of learning support tools.
- 3. The criteria for admission to the module require that candidates are currently working within an NHS Trust. Ideally candidates will have a minimum of two years'

experience in the ambulance service as an Emergency Medical Technician 1 and will have completed the ambulance service EMT1 programme.

- 4. The final award is a Continuing Professional Development Introduction to Pharmacology, 20 credits at Level 4.
- 5. The students have access to a Blackboard site and the University's other range of electronic support such as access to the electronic library facilities. The module has continued to develop with an up to date Blackboard site reflecting contemporary reading lists and links to journal articles. The module Blackboard site has also developed and now includes a number of presentations for students to access on areas such as critical writing and library support. The students also have access to the module leader through phone contact, emails and face to face meetings if this is viable. A module guide is also provided, which guides students to the wider range of support available to students.
- 6. The programme is assessed and run in line with the Academic Framework
