### **Outline Syllabus**

*This module has been designed for new teachers or those who have not previously obtained a teaching qualification. It will therefore address the main areas considered necessary for a teacher to develop skills, knowledge and understanding. These areas include assessing the needs of learners in as broad a perspective as possible, planning programmes and sessions to accommodate learners needs as well as academic requirements, delivery mechanism, assessment and feedback techniques, and evaluation and review procedures. Throughout the module, the students will also be required to present a reflective account of the learning they have experienced.*

### **Learning Activities**

Delivered to incorporate practical teaching and observation. Students will be actively involved in furthering their knowledge regarding the diversity of learners needs, planning schemes of work and session plans, delivering, assessing and reviewing learning sessions. Students will research around these issues, and explore each area in relation to their own subject disciplines. They will also participate in the delivery of a learning session to their peer group; an activity which is designed to consolidate the learning throughout the module.

Formal delivery using a variety of appropriate learning and teaching methods such as verbal exposition, group work, individual work, discussion/debate, presentation-micro-teaching, observation, question and answer and brainstorming.

This module will provide students with an initial level of skills, knowledge and understanding which relates to the requirements of a professional practitioner within

the Lifelong Learning Sector. These will involve considering learners' needs, planning based both on these needs and the assessment requirements, delivering learning, assessing achievement, evaluating practice and reflecting on their role and subject development.
