Outline Syllabus

- Awareness of the macro and micro-level forces that shape professional practice and employment across and within performing arts disciplines;
- Awareness of essential research and academic writing skills and conventions;
- Develop individual capacity to apply relevant processes in the communication of research outcomes.

Learning Activities

This module is delivered in two parts.

Part One of the module consists of multi-programme lectures and seminar sessions in which macro-level themes related to the impact of Political, Economic, Socio-Cultural and Technological forces are explored.

Part Two is taught in programme groups where lecture and seminar-based learning activities build upon the work carried out in Part One. The focus is on the micro-level, subject specific impact of the PEST factors as well as other theories, defining features and practices relevant to the professional context of individual disciplines. Delivery will integrate study skills and appropriate learning resources in support of the research and writing tasks needed to undertake the essay component of the module.

Assessment of the learning outcomes is based on the submission of a detailed PEST analysis covering a specific performing arts sector and a 2000 word essay exploring appropriate discipline-specific themes covered in Part Two of the module delivery. The essay task, which will follow an identical pattern across all disciplines, will be set from within individual programmes.

The module will make use of the institute VLE (Moodle) on which the lectures, presentations and other supporting material will be made available.

Notes

Whilst this is a shared module, each individual programme will produce a separate module handbook detailing the content of Part Two of the module. This will include a detailed and specific bibliography. The module will be subject to scrutiny of the external examiner of each individual programme.
