Outline Syllabus

This module aims to introduce students to the differing elements of social policy in relation to the development of service provision in the field of alcohol and substance misuse. Further to this, a contextual overview of historical and current legislative and policy frameworks within which services have developed will be outlined and social trends in UK society examined.

Consideration will be given to the various perspectives taken and the nature of responses offered by medical, law enforcement and social disciplines as students gain a broader understanding of the differing roles, both professional and non-professional, which contribute to the ongoing development and delivery of service provision.

The opportunity for students to relate their learning to current work experience will be further enhanced through exploration into a range of issues including the current level of integration of knowledge and practice between disciplines and the extent to which provision is unified nationally, with recourse to international perspectives as appropriate.

Comparative evaluation of limiting factors and current debate will consolidate learning in this module as students consider possibilities for future policy making.

Learning Activities

Lectures, group and class discussion, independent study, student presentations and seminars and guest speakers.

Notes

This module provides an overview of social policy both past and present. It encourages students to appraise the development and implementation of legislation and welfare policy and to discuss and analyse how this may influence both positively and negatively upon the context of alcohol and substance misuse practice. Regular tutorials will provide opportunities for informal formative assessment to support student learning and discuss their overall progress.
