## **Outline Syllabus**

How people learn and develop, especially in relation to personal, social, emotional, intellectual and cognitive development. Theories of human development e.g. the work of Piaget, Freud, Erikson, Skinner, Bandura, Bronfenbrenner. Key transitions within the life-course, and the impact of these on development. Self-reliance, self-image and identity, and how they can affect development. Contemporary issues affecting development, such as health, poverty, employment, deviance and environment. Identification of needs and appropriate services available to meet these.

## **Learning Activities**

Lectures will be based upon theoretical perspectives on learning and development and will focus upon key readings. Group work, presentations and discussion will ensure students participate in taught sessions and engage in their learning. Action learning sets will be used to enable students to work together and draw upon expertise within the group. Class discussions will centre on workplace/placement experience, applying theory to practice through examples and group activities. The college's Virtual Learning Environment will be used to encourage debate and discussion surrounding sociological ideas and perspectives. Private study will focus on the development of knowledge of theory in relation to learning and development.
