Notes

In order to meet the NYA requirements this module needs to have 188 hours of placement hours, even though the module total is a maximum of 120 hours. These are only 'notional' hours and act as a guide.

Assignment One

Students will undertake a 1500 report drawing on their practice identifying significant learning in 3 key areas of the 8 core elements of the placement.

Assignment Two

Students will complete a short CV (max 2 sides of A4) which will be used to help gain a level 2 placement drawing on elements identified via the PDP and their level one placement. Also to be submitted is a practice learning log which quantifies hours spent on the placement, and must total a minimum of 188 hours at least 50% of which is face-to-face. Students will design this log during the PDP module for use on placement.
