Notes

The module develops students' professional research competencies. Students will develop the intellectual and practical skills to be able to design a criminology research project and to defend, challenge and critique the research they encounter. Students learn experientially, through engaging the process of producing a research design that is focused on their area of specialist interest. This allows questions about relevant political, philosophical, economic and practical issues that enliven research, to arise in a manner which is integral to authentic research design practice.

The module builds on prior modules and enhances students' abilities to engage in research activities at level 3. For students who are intending to write a dissertation, or undertake a Case Study at level three, this module provides an essential gounding. Students develop a proposal that they can submit to be considered for admission to undertake a dissertation or Case Study.
