# **Outline Syllabus**

Students have the choice of engaging the module by self-initiated placement or studio practice on a semester basis.

This module will run simultaneously with LSAFA2003 Fine Art Practice & Publication. (see Module and Student Handbooks) At the end of the year assessment, all work will be displayed as one complete presentation. Each core module's assessment criteria will then be applied, giving two separate marks.

Students will define their own agreed study fields and objectives. They will be encouraged to develop scholarly work within their broader creative, expressive and personal concerns, via an agreed work programme. Topics may be presented in any agreed expressive medium and seminar system.

- 1) Students follow a substantial programme of artistic production guided by the tutorial and seminar system.
- 2) Students will undertake appropriate study of the creative and expressive potential of materials and processes.
- 3) Students will be encouraged to attend lectures, seminars and field trips to gallery and exhibition venues that will enable them to formulate and articulate discourse relevant to their own practice.
- 4) Research visits will be facilitated by agreement.
- 5) Students will receive appropriate Health and Safety, technical, cultural context and build upon their personal development folio; a short optional field trip is arranged
- 7) A joint reflective statement will be presented at the end of the module

# **Learning Activities**

Students will to a degree shape their own learning outcomes via the Statement of Intent.

Studio seminars form an integral part of activities. Coursewok submissions willbe expected to include evidence of attendance; and notes on PDP, technical inductions, marketing and cultural context seminars.

A formative review occurs at the end of the first semester.
