### Aims

## **Outline Syllabus**

*Students on this module are introduced to a number of influential theoretical concepts concerning the constructedness and 'performativity' of femininity and masculinity, the correlation between gender and literary (self-) expression, as well as the socio-political implications of certain gendered modes and strategies of narration. The main focus of the module is on a comparative analysis of male- and female-authored representations of gender with reference to a series of case studies of literary texts ranging from the nineteenth century to the present. The module concludes with an outlook on current (and possible future) trends in literary representation and academic study of gender relations.*

## **Learning Activities**

Lectures, seminars, private study, written work and on-line tutor support.

## **Notes**

This module is concerned with an analysis of the major historical developments and changes in the literary representation of gender and gender relations. Concentrating on an exploration of the manifold narrative techniques and devices that facilitate, regulate and unsettle the representation of gender in literature, the module aims to open up a debate on the ultimate interdependency of masculinity and femininity as intimately relational gender constructs.
