#### Aims

Acquire knowledge and understanding of the rules of equity and trusts. By application of statute, common law and equitable principles, students shall be able to distinguish between trusts, powers and gifts and the various methods of creating the same. Students shall be able to explore important specialist trust areas including charities and pensions. They shall also be able to understand and apply the knowledge and rules, which govern the administration of trusts and trustees. Finally, students shall be able to understand the consequences of a breach of trust and of fiduciary duty, and th effective remedies available in this event.
