#### Aims

To introduce to the student an understanding of the concepts of punishment, from a theoretical, policy and applied perspective, in the administration of justice.

To introduce students to competing theories of 'justice' and rights in criminal justice, and different theoretical bases of sentencing in the judicial process.

To enable students to understand, critically examine and evaluate the development and use of penal sanctions and punishment.

To develop understanding of factors which influence sentencing outcomes (e.g. race, class, gender) or which discriminate against some of those playing a part in the judicial process (e.g. vulnerable suspects, vulnerable witnesses)

To examine and evaluate critically alternatives to traditional theories of punishment, such as restorative justice and rights-based approaches to justice.

## **Learning Outcomes**

After completing the module the student should be able to:

- 1 Critically understand the theoretical issues surrounding the use and legitimacy of punishment, and its hidden agendas
- 2 Recognise and understand the theoretical concepts which shape notions of 'justice' in judicial procedure and sentencing
- 3 Appreciate the key stages in the judicial process, what can happen at each stage, and which individuals and agencies play a role in deciding the outcome of each stage.
- 4 Evaluate, understand and critically analyse the ways in which discrimination and issues around class, race and other social divisions within courts, prison and community sentences can affect the trial and sentencing process in practice
- 5 Examine, critically compare and discuss the concepts of reductivism and retributivism, linking this to recent UK sentencing legislation
- 6 Recognise the principles of restorative justice, and understand how it affects different groups and procedures in the current judicial process, as well as how its role may change and develop in the future.
