This module will introduce students to the history of sub-Saharan Africa since the advent of European colonial rule in the late nineteenth century. It shows modern African history to be shaped by the character of Africa's place in the world, and by the dynamism of African societies; by the unequal yet ambiguous power relationships between colonial and postcolonial global actors, African elites and peoples; by the tensions of gender, generational and status inequality which have powered social and political change within African societies; by the use and transformation of universalist languages of rights and freedoms by Africans eager to free themselves from oppression and domination; and by the constant interactions between cultures and political systems which make a nonsense of claims that Africa has been outside of world history. The module will first provide a chronological overview of the period, covering colonial rule, decolonisation, and the period since independence. It will then examine a number of over-arching themes in modern African history: gender, health and demography, ethnicity and nationalism, and the history of humanitarianism in post-colonial Africa.
