Outline Syllabus

Method

The first section addresses the methodology adopted for destabilising hegemonic ideas. We will appropriate Foucault's method of discourse analysis for the purpose of exploring sexed violence from a feminist perspective.

Trial by Sex

The second section tackles questions about interpersonal violence which have emerged in western countries over the past four decades and which remain issues today.

Strategies

The third section explores a variety of legislative and non-legislative approaches to violence against women in contemporary discourses.

Learning Activities

Lectures, note-taking, participatory reading, small group discussions, structured use of media resources, structured activities, invited speakers and assessment workshops.

Notes

This module explores and analyses various approaches to, representations of and responses to sexed violence. We question the multiple meanings of 'sex', 'gender', 'violence' and numerous other conceptualisations in order to disrupt popular or common sense understandings of sexed crimes. By examining the role played by culture, ethnicity and sexuality in legal translations of various forms of violence against women, the module raises questions about the violence of law, especially its androcentrism, ethnocentrism and heterosexism
