Learning Activities

Lectures: large group sessions in which all students will receive key information on the issues covered related to the module including what is crime, and key contemporary issues with regard to the police, courts and punishment.

Notes

This module is designed for students studying criminal justice and students studying forensic psychology or LLB Law alongside criminal justice modules. The module aims to explore the criminal justice process in England and Wales. Areas to be examined include: police powers, including the power to stop and search; crime

control and due process models of policing; sentencing and punishment. The role of determining contexts such as class, race and gender will be an integral part of the module. Students will be introduced to the issue of theory, policy and practice.
