#### **Notes**

The Law of Succession is concerned with the disposition and distribution of property belonging to a late, lamented, but now decidedly dead, and deceased, person. In this module, we will be looking at the disposition of a person's estate where he or she had the foresight, mental capacity and wit to draft a valid will, as well as the necessary requirements for a valid will along with the requirements for knowledge

and approval of the contents of the will and concept of undue influence as it applies to wills. We will also study the distribution of an estate where the deceased died without a valid will – either because the will was invalid or because they had no will – and the taxation of that estate. In addition we will look at the family inheritance provisions, which allow disgruntled spouses, partners, dependents and children to ask the Court to "re-write" the will for their benefit. And, finally, we will be looking at the practicalities and procedure involved in acting as personal representatives in the administration of a deceased's estate.
