Outline Syllabus

The purpose of this module is to provide students with an in-depth knowledge of the transnational crises that shaped the world on many political, social and economic levels in the years between the end of the First World War and the outbreak of the Second World War. Starting with the problems inherent in the terms of the Treaty of Versailles and the 'unfinished business' of the First World War in Germany and Italy, this module's content with expand geo-politically outward from Europe, taking students on a journey through the Great Depression in the United States, the failed international intervention in Russia, the rise of militarism in Japan and the global successes and failures of the League of Nations.

Through this journey, students will develop a holistic conception of how the various crises that beset the world between 1919 and 1939 were interconnected, and the solutions proffered – both national and international – were shaped by this transnational experience.
