Notes

This module will require students to consider the law from a Police and Crown Prosecution Service perspective and explain how and why a case may stand or fall within the Criminal Justice System.

Students will be required to critically review aspects of culpability relating to all the elements contained in the Actus Reus, and Mens Rea elements of a crime. Additionally legal defences and case law precedents will be investigated, explained and critically reviewed in relation to the practical application of the Criminal Law. The role of Judge and Jury and the principles of sentencing as revised in the 2003 Criminal Justice Act will also be analysed and reviewed in this module, as will the issue of recklessness and the part it has played and does play within the criminal trial. Arguments relating to the constructing of a legal defence or public prosecution will be analysed, reviewed, evaluated and constructed in relation to conduct, circumstances, consequences and possible defences.

Formative Assessment will include a problem solving essay to develop your problem solving skills.
