Outline Syllabus

This module is a development of Photography in Context in Level 4, but with greater emphasis on broad themes that are currently - or have always been - pertinent to creative photographic practice. You are expected to consider these topics in relation to your own emerging interests. Subjects under scrutiny include the landscape, the shadow, and the exploration of photographic scale. All such themes are set into an historical, cultural and sociological context, which might include the influence of painting, science, sociology or critical theory. Particular emphasis is placed on the symbiosis between visual communication and the realm of ideas i.e. the image and the word. The weekly sessions are intended to be a forum for debate, not merely didactic lectures. Assessment is carried out through a written assignent that refects the contents of the module.

Learning Activities

A number of seminar-based lectures which detail key philosophical and cultural issues and debates which surround contemporary photographic practice. You will actively participate in discussion and engage in activities throughout. You will be expected to make observations, debate with peers and initiate arguments which support your opinions.
