### **Outline Syllabus**

Identification of the development of social and welfare policy from the latter part of the 19th century to the middle of the 20th century. An examination of the role of different political and economic perspectives in relation to health, social and welfare policy. Identification of the role of social and political theory and current ideology. The development of equal opportunity policy, welfare rights and citizenship. An examination of the contemporary changes in demography in relation to social and welfare policies. An investigation of current social and welfare policy in relation to the family, childcare and child protection. Identification of how health, social and welfare policy impacts on inequality, poverty and social exclusion. Evaluate the role of the individual and institutions in affecting health status in Britain. Analysis of the role of government health policy in maintaining health and social care of the individual. An understanding of the impact of education, training and employment policies on the individual and community. An evaluation of contemporary housing, urban and homelessness policies and the welfare of the individual and community. Identification of the role of the consumer when accessing health and social care institutions.
