## Aims

## **Outline Syllabus**

This module is aimed at students who are currently working in placements or intending to work within the social care/welfare areas, or for those looking to explore further some of the themes relating to these areas of work. The wider context of how increasing demands have put greater pressure on the welfare system will be explored, and the impact of such changes on the nature and experience of the service users. It will also consider how the needs of service users are met by social care professionals, and their key roles and responsibilities. It is intended to provide students with a deeper understanding of how processes, structures and competing ideologies inter relate to inform working practices and professional priorities. This is a varied syllabus that will incorporate themes including, anti oppressive practice, empowerment and advocacy within the context of how vulnerable groups and service users, (such as adults with learning difficulties, older people, the disabled, looked after children), engage with the services available. The module will also explore the notion of the mixed economy of care.

## **Learning Activities**

Lectures, workshops, guest speakers, including service user participation and providers' engagement; academic tutorials.

This module focuses on the increasing demands on the welfare system and how they have impacted upon the experience of key service users. It will help to provide a deeper understanding for students who are currently working in placements or intending to work within the social care/welfare field to gain a greater insight into the shifting priorities and working practices in these areas of work. It will allow students to investigate and present a 'case study' focusing on a chosen client group/service user experience of a social care/welfare initiative or policy change.
