Aims

To ensure that students pursuing a career in leisure or recreation management are equipped with significant knowledge of the legal framework surrounding their chosen profession.

To enable students to identify the limitations imposed upon the use of the landscape for leisure and recreation activities, and to make students aware of the legal constraints revolving around the use of premises for the purposes of recreation and leisure activities.

To provide students with the tools to facilitate understanding of contractual obligations regarding membership/entry, prohibitions against discrimination vis-à-vis entry and membership, and the ability to restrict contractual liability through the use of exemption and limitation clauses.

To familiarise students with the key areas of law that will impact their future roles as employees and employers.

To allow students to be cognisant of licensing obligations, permissible and nonpermissible use of customer data and the intellectual property of third parties. To enable students to comprehend the restrictions imposed upon the marketing and advertising of leisure and recreation services.

To make students aware of the civil duty owed to customers/members under tort law and the actions that amount to a breach of the requisite standard.

Learning Outcomes

- Demonstrate an understanding of contract law and in particular formation, formality and termination of contracts especially with regard to membership of leisure and recreation centres.
- 2 Appreciate the significance of employment law and the regulation imposed upon the employer-employee relationship.
- Be aware of the legal restraints imposed upon the marketing and advertising of leisure and recreation services.
- Identify the licensing, data protection and intellectual property obligations that arise in the context of the management of leisure and recreation activities.
- Articulate the legal responsibilities imposed upon managers in relation to the operation of indoor and outdoor leisure and recreation activities, particularly with regard to planning, health and safety, occupier liability, littering and pollution, and fire safety.
