The Programme and Award:

Certificate in Professional Development (CPD) Assessment and management of Minor Illness. The programme aims to prepare practitioners appointed to the role of minor illness practitioners in primary care settings.

Entry onto the programme:

Applicants must be a Registered nurse, or appropriately qualified health professional, with minimum of 2 years post qualification experience

Applicants must demonstrate their ability to study at Level 6

Applicants must be able to show evidence of active involvement in issues relating to minor illness/injuries and health promotion in their current practice setting

The programme is not open to International Students requiring a student visa

Recruitment and Admissions:

Applications will be dealt with initially by Mastercall

Prospective applicants will receive an application pack from Mastercall

Completed applications will be reviewed by the programme leader and applicants will be invited for informal interview

External candidates must have a letter of support from their clinical manager to undertake the programme to include a commitment to protected study time

Pre course, all applicants will be expected to provide a reflective piece of work to be submitted on application. Guidelines for completion of the reflective piece will be provided. This would then be used by the programme leader to judge whether the applicant has realistic expectations for the programme and to gauge the student's academic writing and English language ability. At the same time, it is a useful starting point to tailor learning opportunities to meet the student's needs.

Delivery of the programme:

The programme is delivered on a part time basis over two semesters starting in September and finishing in May with a 2 week break over the Christmas period.

Delivery is via 3 hour teaching sessions delivered one evening every 2 weeks.

Teaching will take place on site at Mastercall Healthcare in Stockport.

Programme assessment:

There are 2 summative assessments associated with the programme:

1. A 2 hour examination
2. A Clinical Competency Document

The programme is assessed in line with the Liverpool John Moores University (LJMU) Academic Framework regulations, accessed via http://www.ljmu.ac.uk/academic_Enhancement/121984.htm

Throughout the programme students are required to complete 80 hours clinical placement at Mastercall Healthcare in Stockport (with the option to complete a

maximum of 20 of these hours in their own workplace setting - to be negotiated with the programme leader).

Please note - Learning Outcome 4 of the programme states that the student will demonstrate competence in a range of practice skills as detailed in the clinical competency document. Achievement of this learning outcome is assessed via the Clinical Competency Document during the 80 hours clinical placement time

The Clinical Competency Document is an assessed component of the module and must be passed this will be assessed by a GP or Advanced Nurse Practitioner allocated to the student as a clinical supervisor during the 80 hours clinical contact time.

Student Support:

Students will be supported throughout the programme by the programme leader, LJMU link tutor, members of the programme teaching team, their Practice Supervisors (who will be GPs or Advanced Nurse Practitioners working in the clinical setting) and an allocated mentor, who will be an ANP who is a member of the programme teaching team.

In addition to the support provided by the programme leader who has overall responsibility for the management of the programme, each student is allocated a mentor. The role of the mentor is to support student learning and development and to monitor student progress through planned tutorial meetings at the start, mid-point and completion of the programme. These tutorials will form the foundation for personal development planning activities in which the student will be encouraged to reflect upon their own learning needs, professional and educational progress.
