Module Overview

Additional Information

This module will enable students to explore how to facilitate lifelong learning in others by developing their mentoring, teaching and assessing skills. In addition, it will provide initial preparation for the sign-off mentor role. In order to be successful students must pass all the practice outcomes in the Practice Mentor Assessment Document. The module uses materials from modules already delivered within the school. The assessment is aligned with the Nursing and Midwifery Council (NMC) Standards to support learning and assessment in practice (2008) and will be assessed by a professional portfolio of teaching and learning activities. against these standards. Reflections on practice are required and assessed against the L5 grade descriptors which is a requirement of the NMC. The final qualification is a Continuing Professional Development - Supporting Learning and Assessment in Practice which will enable students to become a Stage 2 mentor.1. The module learning outcomes and relevant subject benchmark statements are in line with the QAA framework for higher education qualifications in England, Wales and Northern Ireland. 2. The module involves classroom attendance, which is further supported by a range of learning support tools. This is part time and lasts for 15 weeks.3. The criteria for admission to the module require that candidates have been qualified for a minimum of 12 months and are currently working as a Registered Health Professional 4. The qualification is a Continuing Professional Development – Supporting Learning and Assessment in Practice.5. The students have access to a Canvas site and the University's other range of electronic support such as access to the electronic library facilities. The module has developed an up to date Canvas site reflecting contemporary reading lists and links to journal articles. The Canvas site includes a number of presentations for students to access on areas such as critical writing and library support. The students also have access to the module leader through phone contact, emails and face to face meetings if this is viable. A module quide is also provided, which quides students to the wider range of support available to students. Panopto video to support students learning off campus is a feature of the module content6. The programme is assessed and run in line with the Academic Framework Regulations7. Attendance is required throughout the module although some learning material will be available through the Canvas site. 8. The methods for improving the guality and standards of learning are as follows: Liaison and feedback from the students Reports from External Examiner Programme team ensuring the module reflects the values of the current teaching and learning strategy. Module leader updating knowledge and skills to ensure these remain current and relevant9. This is a standalone CPD. A specific external examiner is identified for the programme.10. The approved intake month is flexible.11. The programme codes associated with this module are 35918 (NHS/CPD Apply) and 36143 (Self-funding code) 12.
