## **Outline Syllabus**

This module focuses upon the enhancement of individual expertise required to move the clinician from a position of basic effectiveness within the clinical team to a position of refined functioning, on an individual level, within the speciality. This module content includes advanced respiratory assessment, therapies, ventilation, CXR interpretation, ABG analysis, respiratory physiology and pathology in children, cardiovascular physiology and pathology in children, congenital heart disease in the PICU, pharmacology, haemodynamic monitoring, infection and sepsis in children, nutrition in the critically ill child, gut problems in the PICU, the parent's experience of having a child in PICU and communication in PICU. The module will also look at the patterns of integration of clinical work that are emerging between different professionals delivering care within a setting. It will examine the evidence base for PICU therapies and care, legal and ethical issues in PICU, renal failure and therapies, neonatal intensive care, retrieval and transport of the critically ill child, neurological assessment and pathology in children, neuro trauma and care of the neuro surgical child, burns and trauma, metabolic and oncological emergencies in children, PALS skills, pain and sedation in intensive care, introduction to counselling skills and supporting bereaved parents and professional issues for PICU professionals.

# **Learning Activities**

Taught sessions will utilise key lectures, tutorials, seminars, workshops, skills based teaching, practice based clinical simulation, clincial practice hours and group discussion to facilitate their learning. The 60 clincial practice hours identified in the other section in the learning hours, refer to time spent in practice with the module leader, practice mentors and supernumerary practice placements.
