# **Outline Syllabus**

The historical evolution of criminal justice & penal policy; The development of criminal justice policy since Thatcher; Trends in crime, fear of crime, crime and social exclusion; The Criminal Justice Process, roles & functions of the police, CSOs, CPS, courts, prison, probation and YJB; Theories of justice & punishment: deterrence, retribution, rehabilitation & reparation; Sanctions & influences on sentencing; "Prison works" – contemporary penal policy; The Criminal Justice System and mental illness; Young offenders and desistance, anti-social behaviour; Rehabilitation processes: probation, educational support, Nacro; The 'penal-welfare state', social control, 'net widening', regulation & state intervention; Women in the Criminal Justice System

### **Learning Activities**

Lectures and seminars including group work and group discussion, supported by individual academic tutorials.

#### **Notes**

This module will describe, analyse and evaluate the historical development and application of social policy in relation to criminal justice examining the links between the two. It will consider how popular perceptions and political ideologies influence, change, and lead to the development of policy in the operation of criminal justice and social welfare agencies. It will also look at the effectiveness of criminal justice policy, and in the ways that individuals are affected by policies in action with a particular

emphasis on interrelationships between agencies, and concepts such as rehabilitation and social control.
