Outline Syllabus

Contemporary leadership and management theory. Accountability and autonomy in clinical practice. Effective clinical leadership. legal and ethical practice related to all branches. Effective team leadership. Teaching and learning theory / practice. Expert and capable practice. Quality assurance and clinical effectiveness. Organisational culture. Developing change management skills. Effective decision making in practice. Managing clinical risk and crisis. Managing complex care. Pharmacological management. Clinical supervision and support in practice. Case management. Principles of nurse prescribing, managing stress for personal health.

Learning Activities

Formal lectures and seminar work. A Problem based learning / critical thinking approach to the seminars will be included, students will work in groups which will encourage peer and self assessment throughout the module. Skills will be developed in relation to clinical leadership development. Preparation for registration workshops. Teaching presentations and practice assessments.

The total university delivery time is 60 hours, the students are also allocated 66 nominal practice hours.

Notes

The module enables students to critically appraise a range of leadership and management issues, so as to develop personal leadership competence for their future roles as registered nurses.

The module is also assessment formatively through PBL and scenario based work, self and peer assessment, presentation work and diagnostic assessments.
