Outline Syllabus

Study skills, role of the nurse in the high dependency setting, professional issues, review anatomy and physiology, cardiovascular, respiratory, neurological and renal systems, relating them to conditions and treatments. The principlas and processes of haemodynamic monitoring, respiratory failure, blood gas analysis, nutritional needs, IV therapies, pain and sedation effects and management, fluid balance, principlas of non invasive ventilation, pharmacology, family centred care, parental stress and support and evidence based practice.
