Learning Activities

Lecturers will offer students a working knowledge of a range of research and evaluation methods with critical skills being developed in seminars. Students will be briefed on and directed to computer package exercises.

The evaluation proposal is designed to assist the student to develop a plan for evaluating social work practice which will prepare them for their extended essay. It will require them to critically review various research methods relevant to the evaluation of practice.

The essay is intended to provide the opportunity for students to write at greater length, exploring and critically using research evidence to reflect upon and evaluate

practice. This must also meet the ECDL learning outcomes.
