Outline Syllabus

Partnership working, working within and managing the constraints of legal and procedural frameworks, power relations, roles and responsibilities of safeguarding agencies, concepts of acceptable and unacceptable risk, making judgements, effective communication, managing inherent conflicts between the principles underpinning the safeguarding of children, paramountcy and no delay principles, multi-agency working.

Learning Activities

This module uses and builds on the students' knowledge and understanding gained through the Level 2 safeguarding module, through discussion, exploration and critical analysis of a number of complex and difficult issues / areas of practice e.g. power relations, managing acceptable and unacceptable risks, making judgements. Such discussion and exploration will be facilitated through a combination of lectures, small group discussions, seminars. Lectures will have brief but focused inputs throughout to enable students work through and gain an understanding of the issues/factors

involved in managing complex and competing factors in the area of safeguarding children.
