Notes

This module will chart the trajectory of criminology's engagement with the issue of gender, particularly since the 1970s. It will address initial feminist concerns to render visible the experiences of girls and women and the impact of these endeavours, prior to exploring contemporary concerns regarding the relationship of 'femininities' and 'masculinities' to crime and its control. It will also focus on the relationship between gender, power and male violence. In these ways the module will encourage students to critically address the issue of gender and its significance for the development of criminological knowledge.
