Notes

This module will develop the students' knowledge, skills and professionalism enabling them to more effectively manage patients with specific illnesses or conditions. It has been designed to develop the students' knowledge and ability to manage a range of illnesses and conditions using higher education as a platform. In order to achieve this goal, the syllabus offers a variety of theoretical insights and professional considerations and the content relates directly and specifically to paramedic practice. The underpinning principle is that students are to develop their assessment and management skills whilst working operationally.

- 1. The module learning outcomes and relevant subject benchmark statements are in line with the QAA framework for higher education qualifications in England, Wales and Northern Ireland. The module is aligned to the Level 6 descriptors for a Level 6 Higher Education Qualification.
- 2. The module involves classroom attendance, which is further supported by a range of learning support tools. This is part time over 14 weeks.

- 3. The criteria for admission to the module require that candidates are currently working within an NHS Trust. Ideally candidates will have a minimum of a diploma (level 5). Students are also accepted onto the programme as part of the international top up degrees for nurses and paramedics.
- 4. The final award is a Continuing Professional Development Common Illness and Conditions. 20 credits at Level 6.
- 5. The students have access to a Blackboard site and the University's other range of electronic support such as access to the electronic library facilities. The module has continued to develop with an up to date Blackboard site reflecting contemporary reading lists and links to journal articles. The module Blackboard site has also developed and now includes a number of presentations for students to access on areas such as critical writing and library support. The students also have access to the module leader through phone contact, emails and face to face meetings if this is viable. A module guide is also provided, which guides students to the wider range of support available to students.

- 7. Attendance is required throughout the module; although some learning material will be available through the Blackboard site.

- 10. This is a standalone CPD. A specific external examiner is identified for the module who also covers the BSc students who complete this module. The module is also included in the programme specification for the BSc (Hons) Health and Social Care Development, BSc (Hons) Paramedic Science (International) and the BSc (Hons) Nursing (International), these are referred to as the top up degree for Health Care Professionals who already have a diploma award, 120 level 5 credits.
