# **Outline Syllabus**

It is intended that all projects will be 'live' in the sense of involving a client who has a need for beneficial change that apparently involves changes to a business information system in the widest sense of the term.

The study of the situation must take account of the relevant human activities and students will be expected, where circumstances allow, to adopt the role of facilitator. A reasoned evaluation and selection of appropriate methodologies and techniques must be made, and reflection and commentary should be provided within an action research approach.

The student will negotiate the initial problem specification in the light of initial analysis, and will produce an appropriate project plan. The student will report and discuss progress with their supervisor within some agreed project management process.

Students will make a presentation to a moderation panel.

## **Learning Activities**

The students will undertake a substantial piece of work generally based on their placement. They will be supported by a Project Tutor who will provide guidance. Within teh first four weeks the students must submit an outline of their project for approval and then by mid October produce a Project Plan. At christmas they must produce a Progress Report.
