#### **Notes**

The focus of the module is on the future development and sustainability of children's community nursing services. This will enable students to become proficient, effective change agents and equip them to develop community children's nursing services of the future to meet the diverse needs of children and young people.

The module will examine the key policy drivers responsible for shaping the future of community children's nursing. Overcoming challenges and thinking outside of the box to identify innovative ways to meet future requirements will be explored. This module will encourage and support students to think at a strategic level about the development and organisation of children's services. This will involve both operational and management issues as well as working with key stakeholders to implement a vision for children's community nursing services.

The Practice Evidence Tool must be completed and passed by the end of this module

This module includes community practitioner prescribing which is assessed by an exam. The pass mark is 80%, however the numeracy questions must score 100%. Additionally, if any answers suggest risking the patient's health, the exam will be marked as a fail. The prescribing competences in the V100 Practice Competency Framework Document must also be passed. The prescribing element of this module is graded as pass / fail.

Learning Outcome for V100 Nurse Prescribing
