Outline Syllabus	The module will allow students to apply the literature, theory and method developed in 6100CRIM to the data generated by the student. This will encompass generating original data from a range of different sources such as policy documents, archival research, questionnaires, semi structured interviews and so forth. This will be done in conjunction with an allocated dissertation supervisor who will see the student for a total of 8 hours in the course of the semester, which will be augmented by more general lectures/workshops. The main activities will include:• Data collection and analysis• Writing the methods, analysis, discussion, introduction and conclusion chapters

Additional Information	The module encourages students to generate their own original data on an issue congruent with the themes of the programme and to produce a piece of work which engages critically with theory and method. Therefore, it is designed to enhance the research and analytical skills of students and to encourage them to be proactive, independent learners through constructing a dissertation which either adds to or challenges existing work in their chosen area.
