The assessment has one element:

Design and production of a poster on an area of practice related to children and young people's mental health. The poster will be presented with a 15 minute verbal defence.

The programme delivery will commence in January

1. The programme has taken account of the appropriate levels of the Frameworks for Higher Education Qualifications of UK Degree-Awarding Bodies (FHEQ) and is aligned to level 6 descriptors. This is reflected in the module learning outcomes. The programme has been informed by the most recent QAA Subject Benchmark Statement: Health care Programmes (Nursing) (QAA, 2001; 2015).

2. The module involves classroom attendance, which is further supported by a range of learning support tools. The module is part time and will run for 6 taught session followed by one assessment day event.

3. The criteria for admission to the module require that candidates are currently working/engaging with children and young people. Candidates will have evidence of ability to study at academic level 6, ideally candidates will have a minimum of a diploma (level 5).

4. The final award is a Continuing Professional Development – Engaging in Children and Young People's Mental Health 20 credits at Level 6.

5. The students will have access to a VLE site and the University's other range of electronic support such as access to the electronic library facilities. The module VLE site reflects contemporary reading lists and links to journal articles. The module VLE site also includes a number of presentations for students to access on areas such as critical writing and library support. The students also have access to the module leader through phone contact, emails and face to face meetings. A module guide is also provided, which guides students to the wider range of support available.

Students will have an identified a mentor who will offer tutorial support and guidance in the production of their poster presentation. An Off-Campus Support Gateway is available for students and staff who wish to access LJMU computing and information resources while off-campus. This service is aimed particularly at distance learners, part-time, placement and learning at work students

6. The programme is assessed and run in line with the Academic Framework

7. Attendance is required throughout the module; although some learning material will be available through the VLE site.
