Notes

This module will explore the history, effects and risks of legal and illegal substances that are misused. It will develop a multi-perspective understanding of substance use and misuse both nationally and internationally by enabling students to apply sociological, historical, psychological and cultural perspectives to the study of this subject. It will examine the complex relationships between substance misuse and crime, including legislation and policy relevant to varying substances and criminal activity associated with them. The differing professional and organisational values and ethics that affect policy and law are addressed, as are the methods and philosophies regarding services available to those who misuse substances. This module explores the history, effects and risks of legal and illegal substances that are misused. It examines the complex relationships between substance misuse and crime, including legislation and policy relevant to varying substances and criminal activity associated with them. International and national perspectives on substance misuse are addressed, as are the differing professional and organisational values and ethics that affect policy and law. Methods and philosophies regarding services available to those who misuse substances are also explored.

Learning outcome two is assessed twice in this module due to the wide ranging contemporary debates relating to societies response to substance misuse and the appropriate use of intervention strategies.
