Aims

1. To increase the students specific knowledge of historical or contemporary design and visual arts.
2. To further improve the students ability to research, comprehend, question, compare and contrast, and use concepts and theories relating to the chosen subject.
3. To present written work of a professional standard, using the Harvard System of annotation and reference.
4. To synthesise material from dispersed and distant sources, so that a fresh view is substantiated or an existing view freshly supported.

5. *To analyse visual material independently, and to use visual as well as other evidence in the course of constructing an original argument.*
6. *To show critical capacity in relation to text as well as images, and demonstrate independence of judgement.*

- 4 Synthesise research findings & analysis with own ideas to form arguments.

Outline Syllabus

In order to further develop and strengthen: subject knowledge, research and critical analysis skills, written communication skills, and create a document having potential benefit in terms of future postgraduate study or employment, this module provides the opportunity to submit a professionally presented dissertation or an individual Critical Journal. It allows each student to work independently and in depth in order to produce an 8000 word document from a chosen subject relating to Design and Visual Arts, which must be discussed and agreed with the supervising tutor before any detailed work commences.

Learning Activities

The Module consists of a choice of 2 briefs; either a dissertation or a Critical Journal. The module commences with a detailed introduction and explanation. Subsequently individual project idea/s initially presented to staff for discussion and approval. Following approval small seminar groups will be formed to discuss presentations of work in progress, with all students participating. This module allows substantial time for independent study, and to ensure this time is used profitably, all students are required to produce a synopsis of 1500 words and a rough draft so that staff can monitor and advise on progress. All students will receive one-to-one tutorials from their supervising tutor prior to final production.
