Aims

The aim of this module will be to develop students understanding of the theoretical

approaches to criminal justice and punishment. It will examine models of rehabilitation and punishment and how these in turn influence and affect the practices of criminal justice professional practitioners.

The aim is to provide a comprehensive understanding of the multi-agency approach and engage in critical analysis in relation to how successfully this has been achieved will be encouraged. Additionally students will become aware of the importance of taking a client-centred approach and describe the ways in which effective client relationships can be built and maintained. In particular, students will be required to examine the meanings of 'dangerousness' and 'risk' in order to develop an understanding of pre-sentence assessments, protecting the public, and effectively managing offending behaviour.

Notes

This module will examine the concept of risk, dangerousness, public protection and punishment. It will examine a range of criminal justice models including the rehabilitation model, the medical model, justice, and just deserts models of punishment. The module will balance the rights of the individual offender in relation to the victim and consider how effective the States response is in their punishment of offenders. In particular, this module will focus upon the probation service and its practitioners. It will highlight how the ideals of rehabilitation have now been changed to the management of offending behaviour in terms of reducing risk and protecting the public.

The issues of accountability in those evidenced-based programmes are now the favoured choice in terms of intervention strategies will be contrasted with the experience of staff in terms of decision-making as to what may work with an individual offender. The actuarial justice system and its use of risk predictors aims to take a more scientific view when assessing dangerousness, and as such, this will be analysed and explored to provide students with an up-to-date knowledge of the principals that direct the work of the probation service.
