Aims and Outcomes

Aims To allow students to understand the 'role of constable' in policing, how it relates to themselves and how their actions and decisions affect the legitimacy of policing. The module will secure student understanding of values and their importance within the ethics of policing. The module will develop understanding around critical and reflective thinking and learning. The module will allow students to understand the powers, principles and practices to be utilised in the investigation of crime. The module will examine in depth the concept of police culture and how police officers are socialised into their role and the impact that culture has on policing actions.

Learning Outcomes

After completing the module the student should be able to:

Additional Information

Lectures will provide the students with information and theories. Students will then utilise the process of Attestation to reflect upon how their personal values shape them and their professional development. Students will learn the powers and legislation appropriate to the role of the investigator. Students will explore how ethics and 'policing by consent' contribute to the policing mission. Where relevant and appropriate the concepts of reflective practice, problem solving and resilience will be explored throughout the module.
