The criteria for admission to the module is that candidates are currently delivering the Family Nurse Partnership programme in role of family Nurse or Supervisor and that they have completed or near to completion of the core FNP learning programme. Ideally candidates will have a degree (level 6) however if this is not the case and a candidate does not have a degree they can be offered the opportunity to do a 500 word challenge test to allow the module leader to discuss with them about writing at level 7.
- 4. The final award is a Continuing Professional Development Learning and Reflection in the Family Nurse Partnership, 20 credits at Level 7.
- 5. The students have access to a Blackboard site and the University's other range of

electronic support such as access to the electronic library facilities. The module has continued to develop with an up to date Blackboard site reflecting contemporary reading lists and links to journal articles. The module Blackboard site has also developed and now includes a number of presentations for students to access on areas such as critical writing. The students also have access to the module leader through phone contact, emails and face to face meetings if this is viable. A module guide is also provided which guides students to the wider range of support available to students.
