### **Outline Syllabus**

Visits to specific sites such as Tate liverpool, the Baltic, FACT, The Lowry, The Imperial War Museum North, Open Eye Gallery, Drumcroon Arts Centre and other relevant locations will introduce students to different curatorial proactices and modes of display. Iectures will introduce key theoretical debates around the curation of contemporary art practice and additionsla case studies. The module will look at the history of counter cultures in terms of international display, global markets and at the strategies adopted by local cultures in a global setting. The use of new technologies, Internet, on line exhibition, and other virtual sites will inform this module. Seminars will develop students' ability to critically analyse specific curatorial practices and engage with issues surrounding the relationships between the artist, curator and audience. Peer review will support students in developing their rationale of the exhibition of recent or proposed work for a specific location.

## **Learning Activities**

Site specific visits, lectures, seminars and peer review.

#### **Notes**

This is a theory-based module involving visits to key locations. Students will be expected to document site-specific visits in an appropriate manner including photgraphs, reflective accounts and further research through literature search and review. Engaging with virtual sites in addition to physical locations will be a requirement of this module and should prepare students towards locating and curating their work later in the course.
