#### Aims

Key Historical Studies Component

To engage in the comprehensive appraisal and analysis of a successful public space as a precedent study to inform your subsequent Urban Design project in module 7002MARCH. Then to critically appraise and analyse a seminal building as a precedent study to inform your subsequent Architectural Design project in module 7002MARCH.

Contemporary Theories in Architecture Component

To work with groups of students on current theories in architecture in order that these might inform work in the 'Bigger Design Bites' module and more importantly in their sixth year design modules.

#### **Learning Outcomes**

After completing the module the student should be able to:

- 1 Understand the 'full circle' of a building's genesis, design, construction and use.
- 2 Understand what makes the building a 'clear statement' and why it is notable in cultural terms.
- 3 Understand the need in the student's own work for 'clear statements' and architecture as a contributor to culture.
- 4 Apply relevant knowledge to the 'Bigger Design Bites' in order to limit the time spent in the early stages of these design assignments.
- 5 Explore a contemporary architectural theme through in-depth discussion and the intelligent development of critical arguments.
- 6 Present the results of their individual research and thinking to their peers and assessors and engage in intelligent debate about the work being analysed.
- 7 Write cogently to summarise the contribution each topic makes to contemporary theory.
- 8 Utilise the critical skills learned for the Dissertation assignment in the second semester and for other smaller written assignments.

Key Historical Studies Component

Lecture style presentations of designated building case studies will be presented by each student. The Module component leader will set these out in detail. Illustrated transcripts will be submitted at the end of each presentation.
