## Notes

This module is offered as part of the MA Human Rights and Responsibility and can also be taken as a stand-along Certificate of Professional Development (CPD). It will be presented in an intensive and integrated block and will be offered to both full and part time students. Through seminar discussion and tutorial guidance this module enables students to undertake preparatory work for their Masters project/dissertation. With tutorial support and guidance students will develop and design a research proposal to investigate their chosen area of concern. Group supervision will be used to enable students to reflect on their project development strategies and provide them with formative feedback.

As a CPD, this module should be taken alongside or after the CPD 'Real World Research. Having successfully completed these two CPDs it is possible to continue to a CPD project/dissertation, so providing students with a complete package of 'real world' practitioner/work-based research qualifications. As a CPD the module will appeal to practitioners in the field of Human Rights who want to extend their knowledge of the development of human rights. The CPD will be taught in the School of Humanities and Social Science based at the Mount Pleasant Campus of Liverpool John Moores University. The duration of the module is subject to demand but will be taught in a short block; this may be either over a few weeks or concentrated into a few days of intensive study.

There are no QAA subject benchmarks for this module, but as a Masters level (level

7) certificate, it meets the standards set out by the QAA's Code of Practice Part 1 and the Framework for Higher Education Qualifications in England and Wales (FHEQ).

Applicants will have to satisfy one or more of the following criteria for entry to the CPD:

either have a first degree in a related subject or relevant practical experience. A short essay will be required for entry; TOEFL 6.5 with 7 for reading and writing - or equivalent. Applications will be considered by an admissions panel to determine likelihood of CPD completion and successful achievement. If the panel feels that the applicant is not ready to undertake this CPD they may advise further study prior to another application.

This CPD is subject to the University Modular Framework which regulates all University courses. Assessments are subject to the University's Effective Practice in Assessment (2008) which requires internal and external moderation of work, and feedback will be provided on all assessed work to enable improvement and progression. It is also subject to LJMUs quality assurance and enhancement mechanisms which include annual monitoring and module appraisals, so enabling curriculum development.

The CPD is assessed by a written project proposal. Students will be given one-toone supervision throughout the module and whilst completing the assessment. All students will be allocated a personal tutor who will provide study and pastoral support. Details about the role of the personal tutor will be provided in the CPD handbook. In addition, students will have an induction that will inform them about University services, support structures, and procedures. The induction will also provide an introduction to the module content, assessment processes, and requirements for successful completion of the CPD. Induction will be based on the CPD handbook which will give full details regarding student support and guidance, teaching, learning and assessment, and management and organisation of the CPD.
