## **Outline Syllabus**

During lectures students will gain insight and understanding of the professional, legal, financial and contractual respponsibilities of all parties in relation to the management and organisation of artist-residencies. Students will initiate, plan and implement an artist-residency within an appropriate context. The relationship between the location, specific aims of participants and the artist's practice will be a core focus for continued consideration throughout this module. Taking either the role of artist and/or teacher, students will document the residency in an appropriate format and reflect upon their experiences from conception to completion.

## **Learning Activities**

Lectures, seminar discussions, artist-residency.

#### Notes

This module will support artist/teachers in developing high standards of practice in relation to artist-residencies recognising the significance of effective planning and implementation for both the artist and the host and the importance of location. Students will have the need to work collaboratively with others in order to fulfil the requirements of this module. They might develop collaborations with fellow students or identify appropriate partners to either host or undertake an artist-residency at a site of their choosing. Regular meetings will support students in critically reflecting upon their experiences during the residency and to address issues arising.
