Notes

This module aims to introduce and critically analyse the impact of globalization on public health. It will identify the big ideas of global development and critically examine thier impacts on public health. The spread of modern practices such as biomedicine, health care systems, agricultural methods and consumerism for example are critically explored and alternatives are identified. The module is

assessed in two ways. Students are asked to present a short essay which identifies the core economic, political and social processes involved in globalizing practices. The second assignment is the development of an illustrated report which identifies an aspect of globalization and how it impacts on public health.
