Notes

This module will enable candidates to plan effective learning opportunities within their organisation. Formative assessment will be facilitated through regular feedback

and reflection in class based exercises and tutorials. It will also be provided in the feedback gained from direct observations of practice. The module aims for students to reach Stage 2 Practice Educator Status with the support of the university and the employer agencies who send staff on the module. The Practice Educator Professional Standards (PEPS) for Social Work produced by the College of Social Work (TCSW) in 2012 define Stage 2 Status. These state the following:

'These standards will come into effect in October 2013, and are minimum requirements. They apply to all placements within the academic year 2013/14 and thereafter. From October 2015 all practice educators of social work students must be registered social workers.' (TCSW, 2012)

To reach Stage 2 Practice Educator status students on the module should have: 'Two direct observations of a practice educator candidate teaching, supervising and assessing against the Professional Capabilities Framework . Evidence of workbased competence from taking full responsibility for one social work student and one other being assessed against the Professional Capabilities Framework.' (TCSW, PEPS, 2012)

Practice educator students will supervise one social work student during the yearlong module and must arrange to supervise their 'one other' supervisee with their employing agency once the module is completed.
