Learning Activities

In the first half of the module students are required to attend key 'professional standards' oriented lectures to prepare them for placement activity within a sport science setting. To compliment these sessions, a self-study pack is provided for students to develop their knowledge base in practitioner ethics / code of conduct, client welfare / protection and reflection. In the second half of the module an applied placement is completed. This is supplemented by a programme of group and individual supervisory tutorials, which facilitate reflection on theory-to-practice issues generated by the placement activity. Students' critically understanding of sports science practice in relation to existing theory and research is assessed at the end of the module via a post placement oral presentation and viva and a written philosophy of practice.
